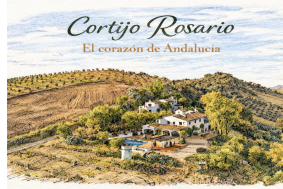

2. What Personal Data Do We Process?

Depending on your interaction with us, we may process the following personal data:

- Full name
- Address
- City or town of residence
- Country
- Telephone number
- Email address
- Date of birth (where required by law)
- Identification details that must be registered under Spanish legislation
- Payment information
- Reservation details



- Communications by email or through our contact form

We do not intentionally process special categories of personal data unless this is necessary, for example where you voluntarily provide dietary requirements, allergies or similar information relevant to your stay.

3. Why Do We Process Your Personal Data?

We process your personal data in order to:

- Manage and confirm reservations;
- Process payments;
- Communicate with you regarding your booking or enquiry;
- Comply with our legal obligations;
- Register guests with the competent Spanish authorities where required by law;
- Improve our services;
- Send newsletters and promotional communications (only with your prior consent).

4. Legal Basis for Processing

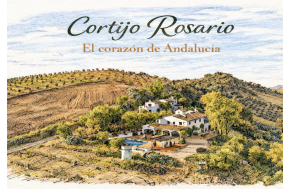
We process your personal data on one or more of the following legal grounds:

- Performance of a contract;
- Compliance with legal obligations;
- Legitimate interests;
- Your consent.

5. Data Retention

We will not retain your personal data for longer than is necessary for the purposes for which it was collected.

Where Spanish tax legislation or tourism regulations require us to retain certain information, we will do so for the legally prescribed retention period.



6. Sharing of Personal Data

We never sell your personal data.

Your personal data will only be shared where necessary with:

- Payment service providers;
- Booking platforms and reservation systems;
- Accountants;
- IT service providers;
- Spanish public authorities where disclosure is required by law.

7. Your Rights

Under the GDPR, you have the right to:

- Access your personal data;
- Request correction of inaccurate data;
- Request erasure of your personal data;
- Request restriction of processing;
- Request data portability;
- Object to the processing of your personal data.
